

MHG Newsletter- RiverShed Ultimate Chef's Table Contest

("The Contest") OFFICIAL CONTEST RULES

1. **TO ENTER:** The Contest is open to residents of Prince Edward Island, Nova Scotia and New Brunswick aged 19 or older only. Only one (1) entry per person is permitted. Entries must be from persons over nineteen (19) years of age. Contest entries can be submitted anytime from May 29, 2018 to June 4, 2018. Contest closes on June 4, 2018. At this time, the winner(s) will be drawn by random draw. No purchase necessary.
 2. **PRIZES:** There is one (1) prize package available to be won. The Prize is offered by the Sponsor (Murphy Hospitality Group) and consists of the following:
 1. Winner will receive one (1) prize package containing 2 tickets to a RiverShed Chef's Table Event of their choice (if available)
 2. Any portions of unused prize will be forfeited.
 3. The Sponsor, at their sole discretion, can cancel the prize without notice.
 4. Prize is non-transferable and has no cash value.
 6. Any costs or expenses associated with the Prize not outlined as included above are the responsibility of the winner.
 7. Once the Prize has been finalized between the Winner and Sponsor, no changes can be made unless approved by Sponsor.
 8. Approximate value of the Prize is \$250 CAD. Winner is not entitled to any difference in the stated and actual value.
 9. Winner must be 19 years of age or older to participate in this prize.
 3. **ELIGIBILITY:** To be eligible, you must be nineteen (19) years of age or older and a resident of Prince Edward Island, Nova Scotia or New Brunswick. You are not eligible if you are:
 1. An employee of Murphy Hospitality Group (the "Sponsor"), their respective affiliates, advertising or promotional agencies, contest judging organization, any participating stores or the prize suppliers; or

Personal information will not otherwise be used or disclosed without consent of the Winner and the Winner's Guests.

2. Prize is not transferable and must be accepted as awarded, with no substitutions in cash or otherwise, except at Sponsor's sole discretion.
3. Sponsor reserves the right to substitute a prize of equivalent or less monetary value if a prize, or any part of a prize cannot be awarded as described for any reason.
4. Sponsor will not be responsible, however, if weather conditions or other factors beyond Sponsor's reasonable control prevent prizes from being fulfilled. In any such event, the winner will not be provided with a substitute prize or cash equivalent. Prizes will only be released to the verified winner.
